CP3P Foundation Blended Learning Program



THE PROGRAM

The purpose of the Foundation certification is to measure whether a candidate has sufficient knowledge and understanding of the PPP Guide to act as an informed team member of a PPP project. The Foundation course is also a pre-requisite for the two Practitioner (Preparation and Execution) courses.

COURSE DESCRIPTION

This certification is aimed at individuals involved in PPP projects, which require a working knowledge of the critical principles of financing PPP projects, who need to know the terminology used and some of the theory behind the PPP financing structures. It is also the introduction to the higher-level Practitioner certification and includes executive decision-makers, senior government employees, and the private sector.

COURSE CONTENT

The Foundation Course covers chapter 1, the Introduction and Overview of the PPP Certification Guide.

- Types of PPP and nomenclature issues
- Where PPPs are used
- Infrastructure sectors

- Introduction to the PPP framework concept
- An overview of the PPP process

STATEMENT OF COURSE AIMS

The main objectives of the Foundation Course are to introduce the PPP concept as an option to procure and manage infrastructure; to scope the term for the

purposes of the PPP Guide, and to explain its main characteristics.

This Foundation Course includes the relevance and features of a proper PPP framework and the entire PPP process cycle, including a description of each of the phases that constitutes the process from a practical perspective. One additional objective of the Foundation Course is to help to create a common ground for terminology regarding PPPs and the PPP process.

EXAMS

- Exams are written online a week after completion of the course.
- The exam is based on chapter 1, Appendix A and the Glossary of the PPP Guide. Practitioners who pass the exam are issued a certificate.
- The exam consists of 50 multiple choice questions per paper, the duration of the exam is 40 minutes and it is a closed-book exam.
