You can view and download these documents from the platform, as well as access the database profile it is associated with.

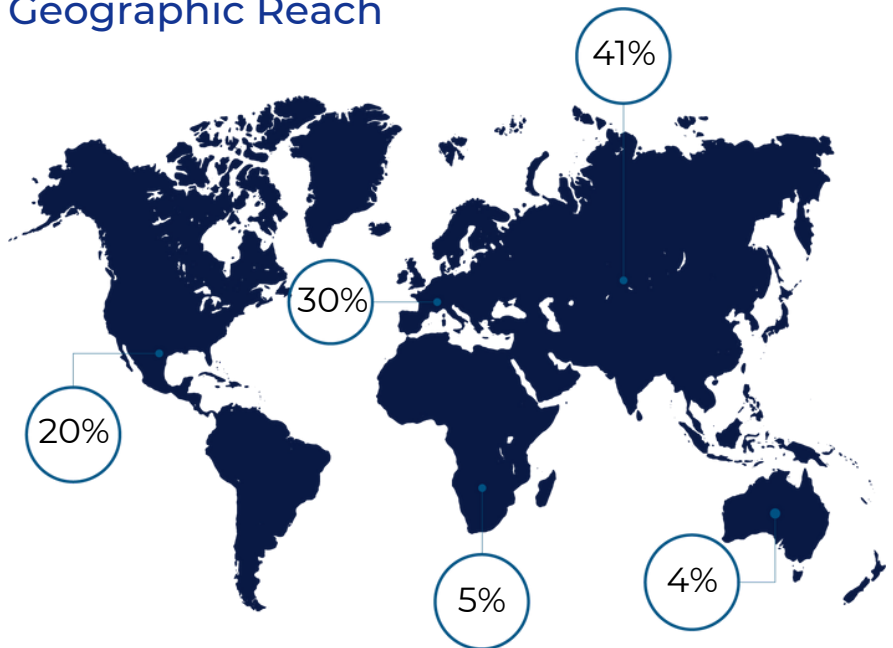

The 10th annual Africa Renewable Energy Forum returns to Morocco from 14-15 November at the Les Jardins de l'Hotel, in Marrakech.
This meeting will explore opportunities for renewable energy project development across North & West Africa under the support of the Ministry of Morocco, Spain, CHAD, MAKEN, AMEN, AMEN, Energy Charter Secretariat and Global News.
Download Program
The desert has long been recognized for its huge potential to deploy solar generated electricity on a large scale, providing electricity through off-grid solutions to enable agriculture development and economic empowerment.
Overseas Solar Power Station (OSPS) - the world's largest concentrated solar power plant - in one example, with the first phase (Phase 1) already providing 100 MW of the total 300 MW capacity. Spanning 100 hectares, Phase 1 CSP has already reduced Morocco's annual carbon emissions by hundreds of thousands of tonnes, with the first phase now in progress.
This year's Africa Renewable Energy Forum will explore Africa's potential to become the world's largest solar power zone, focusing on leveraging private sector financing and partnerships for long-term economic growth and sustainability.
Participants will hear from Cornelius Mathias, Senior Vice President of DSI Energy, in the panel discussion.
