#### ASSIGNMENT DESCRIPTION

IFC will advise the Government of Odisha, India to roll out a network of between 6-12 low cost hospitals across the state on a PPP basis.

These hospitals will be designed to provide modern and quality healthcare services at affordable rates for the next few decades in the state.

IFC will advise the Government on the following broad aspects:

1. Selection of bouquet of services
2. Identification of possible sites
3. Design templates/ architectural briefs for the hospitals based on modern trends aimed at minimizing capital and operational costs while enhancing quality of clinical services
4. Financing of the project
5. Transaction advisory: selection of private partners to design, build finance, operate, manage and transfer assets

The Hospital Planning and Design Consultant will assist IFC in surveying sites available and in making detailed recommendations in designing low cost hospitals from both capital expenditure and operational expenditure using World Class knowledge and innovations. The consultant is expected to develop design specifications and recommendations, architectural briefs, standard operating procedures, incorporating energy efficient and operational efficient design concept for 200 bed hospitals to be developed across the state of Odisha in India. These recommendations will be used for financial evaluation of

the project and will be shared with operators as recommended design concept and architectural briefs to develop low cost hospitals in Odisha. Low cost implying both low Capital Costs and Low operating costs while complying with minimal required safety and clinical quality standards such as NABH and IFC performance standards
