The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. 73 including the section from km 33.000 (design chainage km 35.400) to km 71.640 (design chainage km 86.855) (approx. 51.455 km) (design length). The Authority had resolved to augment the existing road from km 33.000 (design chainage km 35.400) to km 71.640 (design chainage km 86.855) (approximately 51.455 km) (design length) on the Gagalheri-Saharanpur-Yamunanagar (UP/Haryana Border) section of National Highway No. 73 (hereinafter called the "NH 73") in the State of Uttar Pradesh by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded.
