The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. 72A and 73 including the section from km 0.000 (km 22.825 of NH-73) to km 16.000 (Design chainage km 17.900) of NH-72A and from km 0.000 (km 167.800 of NH-58) to km 33.000 (Design chainage 35.400) of NH-73 (approx. 53.300 km). The Authority had resolved to augment the existing road from km 0.000 (km 22.825 of NH-73) to km 16.000 (Design chainage km 17.900) of NH-72A and from km 0.000 (km 167.800 of NH-58) to km 33.000 (Design chainage 35.400) of NH-73 (approximately 53.300 km) on the Chutmalpur-Ganeshpur and Roorkee-Chutmalpur-Gagalheri sections of National Highway No. 72A and 73 respectively (hereinafter called the "NH 72A and NH-73") in the States of Uttarakhand and Uttar Pradesh by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded.
