The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. NH-87 (New NH No. 9, 109) including the section from km 42.791 (design chainage 43.446) to km 88.000 (design chainage 93.226) (approx. 49.78 km). The Authority had resolved to augment the existing road from km 42.791 (design chainage 43.446) to km 88.000 (design chainage 93.226) (approximately 49.78 km) on the Rampur-Kathgodam section of National Highway No. 87 (new NH No. 9, 109) (hereinafter called the "NH-87 (New NH No. 9, 109)") in the State of Uttarakhand by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded.
