Sub: 4-Laning of Lucknow-Sultanpur section of NH-56 from km 11.500 (design chainage km 11.500) to km 134.700 (design chainage km 138.925) in the State of Uttar Pradesh under NHDP Phase-IV on hybrid annuity mode.

Dear Sir,

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. 56 (New NH-731) including the section from km 11.500 (Design Chainage 11.500) to km 134.700 (Design Chainage 138.925) (approx. 127.425 km). The Authority had resolved to augment the existing road from km 11.500 (Design Chainage 11.500) to km 134.700 (Design Chainage 138.925) (approximately 127.425 km) on the Lucknow-Sultanpur section of National Highway No. 56 (New NH-731) (hereinafter called the "NH 56 (New NH-731)") in the State of Uttar Pradesh by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded.
