RFP for Four Laning of Kagavadar - Una section of NH-8E from km 139.915 to km 180.478 (Design Chainage from Km 140.470 to Km 181.450) (Package-IV) in the state of Gujarat on Hybrid Annuity Mode under NHDP Phase IV

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. NH-8E including the section from km 139.915 to km 180.478. The Authority had resolved to augment the existing road from km 139.915 to km 180.478 (design chainage from km 140.470 to km 181.450) on the Kagavadar - Una section of National Highway No. 8E (hereinafter called the "NH-8E") in the State of Gujarat by Four-Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded. Brief particulars of the Project are as follows:
