RFP for Four Laning of Mahuva to Kagavadar of NH-8E from Km. 100.110 to Km 139.915 (Design Chainage from Km 100.450 to km 140.470) (Package-III) in the State of Gujarat on Hybrid Annuity Mode under NHDP Phase IV.

The Government of India had entrusted to the Authority the development, maintenance and management of National Highway No. 8E including the section from km 100.110 to Km 139.915 The Authority had resolved to augment the existing road from km 100.110 to Km 139.915 (design chainage from km 100.450 to km 140.470) on the Mahuva to Kagavadar section of National Highway No. 8E (hereinafter called the "NH-8E") in the State of Gujarat by Four Laning thereof (the "Project") on design, build, operate and transfer (the "DBOT Annuity" or "Hybrid Annuity") basis, and has decided to carry out the bidding process for selection of a private entity as the Bidder to whom the Project may be awarded.
