Implementation of the proposed Inland Water based passenger ferry transportation service (Phase 1) as a Private Public Partnership with the Government of Sri Lanka (GOSL)

The Sri Lanka Land Reclamation and Development Corporation (SLLRDC) under the Ministry of Megapolis and Western Development (GOSL) invites potential candidates to indicate their interest in implementation ("the Implementation") of the proposed Inland Water Transport Project (Phase 1). The Implementation includes design, build, operation and management of the Wellawatte - Battaramulla (IW1) ferry system in compliance with the Megapolis Transport Master Plan developed by the GOSL in 2016. As proposed, the implementation of Inland Water Transport ferry service on IW1 is intended be the first phase of a water based transport system that is foreseen on additional routes of Fort - Union Place (IW2), Mattakkuliya - Hanwella (IW3) and any other routes (including ocean connectivity) found to be feasible.

Candidates will be shortlisted on the strength of the EOIs which comprises a responsiveness check, financial capacity and operational experience evaluation. For the pre-qualified candidates a detailed RFP document will be made available. The selected candidate would be bound by all the terms of the PPP agreement to be entered into with the SLLRDC.
